DEİK / Türk-Güney Afrika İş Konseyi tarafından Güney Afrika Cumhuriyeti Devlet Başkan Yardımcısı Sayın Kgalema Motlanthe'nin Türkiye ziyaretleri vesilesiyle İstanbul, Maslak Sheraton Otel'de 25 Mayıs 2010 tarihlerinde Güney Afrikalı firmalar ile ikili görüşmeler, 26 Mayıs 2010 tarihinde ise Konuk Devlet Başkan Yardımcısı, Güney Afrikalı ve Türk Bakanlar, TOBB ve DEİK Başkanı Sayın M. Rifat Hisarcıklıoğlu'nun katılımıyla Türkiye-Güney Afrika İş Forumu gerçekleştirilecektir.

Sahra Altı Afrika'nın en büyük pazarı ve Sahra Altı Afrika ülkelerine giriş için en uygun basamak olan Güney Afrika Cumhuriyeti, Afrika kıtasının toplam sınai üretiminin %40'ını, toplam GSYİH'sinin %25'ini, kıtanın toplam elektrik üretiminin %50'sini ve maden üretiminin %45'ini gerçekleştirmektedir. Dünya manganez cevheri kaynaklarının %80'i, krom kaynaklarının %68'i, platin grubu metallerinin %56'sı ve altın rezervlerinin %41'ine sahip olan ülke en büyük ikinci altın üreticisi ve en büyük platin ve krom üreticisi konumundadır.

Türk firmaları için özellikle makine ve ekipmanlar, sanayi kimyasalları, tekstil ürünleri, otomotiv ana ve yedek parçaları, kağıt ve kağıt ürünleri, elektronik eşya, jeneratörler, transformatörler, mobilya, tıbbi malzeme, plastik ürünler, kozmetikler, gıda ürünleri, petrol yağları, demir ve çelikten inşaat aksamı, pompa, mutfak eşyası, ev tekstili alanlarda ihracat potansiyelinin mevcut olduğu Güney Afrika Cumhuriyeti ile 2009 yılındaki ticaret hacmimiz 1,9 milyar dolar düzeyinde olup Sahra Altı Afrika'da en fazla ticaret yaptığımız ülke konumundadır.
